Minutes of the 2020 Annual Meeting

Annual Meeting of the Members Monday, January 27, 2020 Sinclair Community College

Pursuant to notice, the Annual Meeting of the Members of the Dayton Council on World Affairs, an Ohio non-profit corporation (the "Council"), was held at Sinclair Community College at 5:30 p.m. on January 27, 2020. Members constituting a quorum were present for the transaction of business.

Members attending the Annual Meeting were provided with the program for the Annual Meeting which included the agenda and proposed meeting minutes of the 2019 Annual Meeting. Each table also received one copy of the Global Dayton Executive Summary and Country Report, part of the forthcoming Global Dayton Report co-sponsored by DCOWA in conjunction with the City of Dayton.

The President of the Council, Vaughn Shannon, called the meeting to order at 5:35 p.m. and presided as Chair of the meeting. The first item of business was approval of the minutes from the 2019 Annual Meeting of members and Board of Directors. Upon motion made and seconded, the minutes were approved and adopted.

The Treasurer's report was presented and approved by the members present.

The slate and Directors and Officers were presented to the members. Upon motion made, it was resolved by the members that the slate of Officers recommended by the Nominating Committee was approved. Derek Petrey was named Vice President of the Council and Heather Atkinson was named Secretary for the Council.

With no further business being presented, and dinner and the keynote by Robert Stokes of PeaceTrees Vietnam still awaiting, a motion to adjourn was made and approved and the meeting adjourned at 6:05 p.m.

President's Report

Fellow members, this has been an unprecedented year for DCOWA and the world, with a once-in-a-century pandemic challenging us all to reimagine how safely to continue the work of society and the work of non-profit service. It was just a year ago, when we welcomed Keynote speaker Robert Stokes of PeaceTrees Vietnam to our 2020 Annual Meeting dinner, that the first case of COVID-19 was discovered in the US.

The last live event before the state-wide shutdown in March was the rollout of the Comprehensive Global Report for the Dayton Region at the Carillon Historical Park. The event was in conjunction with a Dayton naturalization ceremony and was well attended. Thanks again to fellow Board Member Carolyn Rice for her inspiration and work, and thanks to the tireless work of the Global Dayton Task Force, led by former JCOWA member Erik Collins Director of Montgomery County Community and Economic Development. With establishments shut down and large public gatherings discouraged, we neither raised nor spent much in terms of funds, but we did adapt and move to online programming to serve our membership and the broader community. We suspended the monthly Global Views/Local Brews talks for 2020, as well as the Great Decisions lectures held through UD's Osher Lifelong Learning Program. We also had to defer on the 25th anniversary celebration of the 1995 Dayton Accords due to Covid, but look forward to returning to these great programs in the fall of 2021.

We did continue our annual hosting of NCUSCR's China Town Hall in November, this year online of course, featuring Keynote Speaker Ray Dalio, founder and co-Chairman of Bridgewater Associates, and included insights from local China expert and geopolitical consultant Sam Kessler.

2020 was a year for building bridges with other organizations and Ohio's other world affairs councils. In conjunction with the Stimson Center, June 15th we hosted an online panel discussion on the US-South Korea Alliance Amidst Uncertainty, 70 years after the start of the Korean War. We co-sponsored a Columbus Council event held September 1st, called Women in the World: Global Poverty, Gender and Race, featuring Gayle Smith, President and CEO of the ONE Campaign. On September 21st, we paired with Dayton Rotary in welcoming General John Allen discuss Geopolitics during the COVID-19 Pandemic. In October, DCOWA President Vaughn Shannon joined members of the Cleveland, Columbus, Northwest Ohio and Cincinnati/North Kentucky councils on a panel highlighting our youth programs to the annual meeting of the Ohio Council for the Social Studies.

We also spent time modernizing our online presence, including Vice President Derek Petrey's makeover of the application process for the Pfeife Smith annual scholarship. We look forward to the return of youth programming for our JCOWA programs when conditions allow, but we can spread the word on the scholarship and encourage applicants to apply by May 1, 2021.

This year, Treasurer Gary Shoup is stepping down from that position and from the Board. We thank him for his detailed attention and unfailing service to this important position. The Nominating Committee and Board recommend Board Member Katherine Rowell to the position of Treasurer, with your approval tonight. If we could get motions to approve this appointment to the Executive Committee, we thank you for your time and continued support.
