President's Report

2011 was an outstanding year for DCOWA. Here are just a few examples of the many accomplishments achieved:

- Although our partnership with Wright State University's University Center of International Education has proven to be of great benefit to both organizations, we amended our agreement this year to reflect our evolving relationship. Likewise, we entered into a Memorandum of Understanding (MOU) with the Dayton International Peace Museum to formalize ways we can work together to promote each other's programs and mission.
- As a result of our successful application to the US State Department, DCOWA
 was granted a one-year provisional status in the International Visitor Leadership
 Program. UCIE administers the International Visitor Program, and we have
 hosted groups from Russia and Turkmenistan to Dayton this fall.
- The youth programs offered through Junior Council on World Affairs (JCOWA) continues to grow with more than 250 students members located in 16 regional high schools. JCOWA added one new regional event to its usual lineup of programs. In October, JCOWA held its first International Career Day attended by more than 110 students. JCOWA students at four high schools planned programs on September 11th to honor the tenth anniversary of the September 11th tragedy.
- DCOWA executed a successful end of year appeal for youth programs, raising more than \$2,500.
- The adult programs varied from topics like peace through trade and nuclear security to learning more about the current situation in Iraq, Libya, and China.
 We offered both the Great Decisions discussions and Insights programs through the Osher Life Long Learning Institute at UD.
- The Nominating Committee recruited a diverse group of new board members that will energize the organization and set the stage for future success.

All in all, I am very proud of all we have been able to accomplish throughout the last year. Unfortunately, the unrest generated by the "Arab Spring", the DCOWA trip to Egypt entitled "The Splendor of the Nile" originally scheduled to happen in September 2011 was postponed to September 2012. We remain optimistic that it will be a spectacular opportunity for those who want to travel and expand their horizons.

It has been a real honor to serve as President of DCOWA for the last two years. I extend my deepest thanks to the DCOWA Board, Wright State University and UCIE staff, and my fellow DCOWA members for the chance to work with all of you to fulfill the mission of DCOWA. I am excited about DCOWA's future and am very confident that 2012 will see DCOWA continue to grow and thrive.

International Visitor Leadership Program

In February 2011, Wright State University, University Center for International Education in collaboration with Dayton Council on World Affairs received provisional membership into the US State Department's International Visitor Leadership Program.

The International Visitor Leadership Program (IVLP) is the U.S. Department of State's premier professional exchange program. Launched in 1940, the IVLP is a professional exchange program that seeks to build mutual understanding between the U.S. and other nations through carefully designed short-term visits to the U.S. for current and emerging foreign leaders. These visits reflect the International Visitors' professional interests and support the foreign policy goals of the United States.

During the last year, Dayton was able to host a group of Science Technology Engineering and Mathematics (STEM) educators from Russia to learn about *Innovative STEM Curriculum*; a group of government officials from Turkmenistan to learn about *Public Transportation*; and a group of government officials from Iraqi to learn about *Government Transparency*. We hope to apply for full membership into the network in 2012.
